Recognition of a New Guide

"The renewal should be done once in five year".These Regulations will come into effect from January 2013.

1. A qualified faculty member working in an academic department / Institution affiliated to this University is eligible to be recognized as a Guide for the Ph.D., programme of this University.
2. Willing / Interested Faculty Members shall apply through proper channel for recognition by duly submitting the Ph.D., Guide recognition application form – FORM VIII as mentioned in the Ph.D. Regulations along with all the required documents.
3. a) In the Faculty of Medicine, Dentistry and Indian Medicine & Homoeopathy Degree Courses, the candidates who have possessed ten years teaching experience / clinical experience after postgraduate qualification are eligible to be a recognized guide of this University.
b) In the Faculty of Medicine, Dentistry and AYUSH, the Ph.D., qualified candidates who have possessed 5 to 10 years of Postgraduate Teaching experience and one year of research experience after Ph.D., are eligible to be recognized as a Guide for the Ph.D., Programme of this University.
c) In the faculty of Allied Health Sciences, the candidates who have possessed twelve years of experience after postgraduate qualification are eligible to be a recognized guide of this University. In addition to the postgraduate teaching experience, the candidates in the faculty of Pharmacy, Physiotherapy and Occupational Therapy should possess three years research experience and the candidates in the faculty of Nursing should possess two years Research experience.
4. Apart from the above mentioned post graduate teaching experience and research experience, the applicants should have published three research articles in an Indexed Journal in National / International level as a author or Co-author.
5. A recognized guide who is registering himself / herself for pursuing Ph.D., programme should not admit new candidates till they complete their Ph.D., Programme.
6. The duties and particulars of Guides are mentioned in Sl. No. 9 of the Ph.D Regulations 2010.

NEW RECOGNITION II

RECOGNITION OF A NEW CO-GUIDE

"The renewal should be done once in five year".These Regulations will come into effect from January 2013".

- 1) A Faculty member working in recognized Post Graduate Departments/ Institutions affiliated to this University is eligible to be recognized as a Co-Guide for the Ph.D research programme.
- 2) Willing / Interested Faculty Members shall apply through proper channel for recognition by duly submitting the Ph.D., Co-Guide recognition application form – FORM XI as mentioned in the Ph.D. Regulations along with all the required documents.
- 3) a) A person shall be recognized as a Co-guide in any Faculty of Medicine/Dentistry/Nursing / Pharmacy/Indian Medicine & Homoeopathy/Physiotherapy/Occupational Therapy and allied disciplines, if he/she possess post graduate degree with atleast 5 years of P.G. teaching experience in the University departments (or) in any approved affiliated post graduate teaching institution (or) in a recognized research institution of the University with atleast 2 (Two) research publications as the Principal author (or) co-author to his/her credit in any accredited / indexed journal.
b) In the Faculty of Medicine, Dentistry and AYUSH, the candidates who have possessed 3 to 5 years of Postgraduate Teaching experience and one year of Post Ph.D., Research experience are eligible to apply for recognition as a Co-Guide.
- 4) The approved co-guide shall submit his/her consent letter while accepting the request of the candidate to officiate as co-guide for his/her research leading to the award of Ph.D. Degree.
 - i. A Co-Guide is eligible to sign for a maximum of 6 candidates.
 - ii. The duties of Co-Guide are mentioned in No. 10 of the Ph.D Regulations.
 - iii. The Co-Guide must be from the same speciality & working in the Department where the candidate proposes to carry out his/her research work.
 - iv. The Faculty Member registered and recognized as a Co-Guide by this University is eligible to become a Guide after satisfying all the rules and regulations of the University.
 - v. A recognized Co-Guide who is registering himself / herself for pursuing Ph.D., programme should not enroll new candidates till they complete their Ph.D., Programme.
